National Commission for Protection of Child rights (NCPCR) is a statutory body constituted under the provisions of the Commission for Protection of Child Rights (CPCR) Act, 2005 (4 of 2006) for the protection of child rights and other related matters.

- 2. Child marriage is solemnized from time to time in various rural and tribal belts of the Country but in few communities this has been a practice which is followed in a dedicated manner during some specific time periods of the year. In India, Akshaya Tritiya, also known as Akti or Akha Teej, is an annual spring time festival. Reports through various media sources suggests that a large number of child marriages take place during this period. This year Akshaya Tritiya or Akha Teej will be celebrated on 3rd May, 2022.
- 3. You must be aware that the PCMA 2006 seeks to prevent child marriages by making certain actions punishable and by appointing certain authorities responsible for the prevention and prohibition of child marriages. Section 13 (4) of PCMA,2006 states that "for the purposes of preventing solemenisation of mass child marriages on certain days such as Akshya Trutiya, the District Magistrate shall be deemed to be the Child Marriage Prohibition Officer".
- 4. The Commission being an apex body for safeguarding Child Rights and in accordance with its functions as mentioned in Section 13 (1) (a) of the CPCR Act 2005 requests you to give **urgent directions** to all District Magistrates or Collectors / CMPOs of all districts of your State/UT to complete below mentioned **activities** before 20th April 2022 (if not done so far),as a proactive step for prevention of child marriages:
 - i. Undertake awareness programmes at village, panchayat, block, urban/ward, zila tehsil level .
 - ii. Conduct meetings regarding awareness programmes on Child Marriage With CDPOs, CWCs, CWPOs ,AWWs, religious priests who may be responsible for performing marriages and service providers during marriage

- iii. Prepare a **school wise list** of children who are drop out, out of school and not attending school regularly.
- iv. Prepare a school wise list of children absent from school without intimation to the Principal or Head Master of the school in accordance with Rule 2B (2) of Child Labour (Prohibition and Regulation) Amendment Rules, 2017.
- This list must be prepared by Education Department of the district and shared with the DM/CMPO of the district.
- vi. DM/CMPO must identify children from these lists who can be at risk of child marriage. Family counseling and proper inquiry of all such identified children must be ensured to prevent any possible child marriage.

The details of activities, topics to be covered must be followed as given in Annexure I. The same must be filled and submitted on the link i.e https://ncpcr.gov.in/childmarriage.

- 5. The Commission assumes that all the DMs/CMPOs will undertake the above steps in order to discharge their duties given under the role of a CMPO. Thus, officials may submit a report of these activities conducted in their districts, to this Commission by 21st April 2022.
- 6. Further, NCPCR in presence of SCPCRs will hold district wise meetings from 21st April 2022 with following officials to review the status of activities conducted by the authorities of each district of the State. The schedule of the meetings which will be held online will be shared in due course.


