ORDER

As per the Government order referred as 4th above permission has been granted to Government departments to avail the service of M/s MSTC Ltd, for disposing of scrap vehicles/materials through e-auction for a further period of three years.

As per circular referred as 5th above it has been directed that henceforth all Government departments, Local Self Government Institutions and all other institutions under Government shall make use of the service of M/s MSTC Ltd for the sale of usable or scrap vehicles/materials and the sale of such items shall not be made by any other means without the consent of the Government. As per the circular read as 6th paper above directions have been issued to the effect that all Government departments, PSUs, Grant in aid Institutions or any other Government entities shall use MSTC or GeM platform for sale of any usable Serviceable articles arising out of Government offices/PSU/LSGIs, it was also insisted that the said officers/Institutions shall not conduct sale of any such items by any other means without prior permission of Government.

In the meanwhile, the Director Kerala State IT Mission vide his letter read above, has reported that e-auction India has been envisaged as a single platform to cater to various kinds of Government Departments and PSUs. NIC had offered to provide e-auction instance to Kerala with a condition that it would be free of cost for all those States who are funding the NIC e-Procurement system. The Director has requested to grant permission for using NIC's e-auction platform for auctioning for Government Department and Institutions.

There is a lacuna in the Circular read as 6th above that GeM Platform has omitted to include for using auctioning of unserviceable stores and materials even if Government have decided to use GeM also along with MSTC for auctioning of unserviceable/scrap stores articles and materials.

In the above circumstances Government are pleased to order that all Government departments, Local Self Government Institutions and all other institutions under Government shall make use of the service of e-auction platforms of M/s MSTC Ltd or GeM or NIC (NIC e-Auction India services) for the sale of any usable/unusable /Serviceable /Unserviceable Stores, materials/articles including scrap and old vehicles. It is also insisted that the said offices/Institutions shall not conduct sale of any such items by any other means without prior permission of Government. The choice of acution platform in left to the users to be exercised on the basis of cost effectiveness and user friendliness.

Sub:- Finance Department-Availing the Service of M/s MSTC or GeM for auctioning any serviceable and usable stores in Government Departments, Local Self Government Institutions, Autonomous bodies, Grant in aid institutions under Government-Directions issued-reg.

As per the order referred first above Government have adopted the system of e-auction for sale of confiscated vehicles/scrap vehicles, unusable materials etc. Accordingly common agreement was executed with M/s MSTC for the speedy disposal of the above said items and it has been directed vide Government orders read 2nd and 3rd above to use the MSTC platform for the sale of confiscated vehicles/scrap vehicles/unusable materials.

The contract with MSTC has been extended upto the period of 19/09/2024 vide Government order 4th cited. As per the Circular read above, directions have been issued that all Government Departments, Local Self Government Institutions and all other Institutions under the Government shall make use of the above mentioned services of M/s, MSTC Ltd. It is re-iterated that as long as the contract exists between Government and M/s MSTC disposing off the usable or scrap vehicles/materials, and the sale of usable or scrap vehicles/materials shall not be made by any other means without the consent of Government.

The Government Orders read above does not cover the auctioning and sale of usable and serviceable stores. Hence MSTC may also be utilised as e-auction platform for the sale of usable and serviceable stores also. All the Government Departments, PSUs, Local Self Government Institutions, Autonomous bodies, Grant in aid institutions or any other Government entities shall use MSTC / GeM platform for sale of any usable, serviceable articles arising out of Government offices/PSUs/Local Self Government Institutions. The said offices/Institutions shall not conduct sale of any such items by any other means without the prior permission of Government.
