#### NOTIFICATION

- S. R. O. No. 597/2013. In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:—

#### RULLES

- 1. Short title and commencement. (1) These rules may be called the Rules of Business of the Government of Karala (1st Amendment) Rules, 2013.
  - (2) They shall come into force at once,

33/3702/2013/DTP.

- 2. Amendment of the Rules.—In the Rules of Business of the Government of Kerala, in Part II, in the FIRST SCHEDULE,—
  - (1) under the Heading "List of Departments",---

Against serial number 34 and entry, "Social Welfare Department" the following shall be substituted, namely,—

"Social Justice Department"

- (2) under the Heading 'DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT'
- (i) Against serial number XXXIV and entry "SOCIAL WELFARE DEPARTMENT" the following shall be substituted, namely:—

## "SOCIAL JUSTICE DEPARTMENT"

(ii) Against sub heading A and entry 'Social Welfare' under serial number XXXIV the following shall be substituted:---

"A. Social Justice"

- (iii) Against entry "1. matters related to the Department of Social Welfare" under sub heading A of serial number XXXIV the following shall be substituted:—
  - "1. Matters relating to the Department of Social Justice"
- (iv) Against entry "4. Child Welfare Programme of Social Welfare Department" under sub heading B of serial number XXXIV the following shall be substituted:—
  - "4. Child Welfare Programme of Social Justice Department"

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 64/2012/SWD dated 31-10-2012 Government have decided to rename the 'Social Welfare Department' as 'Social Justice Department'. Accordingly, necessary amendment is to be made in the Rules of Business of the Government of Kerala.
