ORDER

Poshan Abhiyan (Sampushta Keralam) is a Centrally Sponsored Scheme funding in the ratio 80:20. As per reference read as 1st paper above Government of India had revalidated an amount of Rs.3748.38 lakhs for utilization in the financial year 2021-2022 and the corresponding state share is Rs.937.095 lakh. So the total fund for Sampushta Keralam comes to Rs.4685.475 lakhs (3748.38+937.095).

2) In pursuance to PFMS norms, a State Nodal Account (SNA) was created in the HDFC Bank, Trivandrum Branch with Account No.50100377788440 to deposit Central and State share for NNM (Sampushta Keralam). As per the letter read as 2nd paper above Director, Women & Child Development Department has informed that the funds were allocated to nearly 300 sub offices for conducting the various activities under the scheme it is not possible to recall the funds back and deposit it in the SNA account during the financial year as this will affect the implementation of the scheme. Therefore only by the fag end of the financial year the funds were asked to be surrendered such that maximum expenditure for the amount allotted for carrying out the activities could be made. Now the actual expenses as on 31.03.2022 is 3031.39 lakh. Since the Central & State share amounts to Rs.4685.475/lakh, the unutilized portion is Rs.1654.085 lakh (4685.475-3031.401).

This has to be transfer credited to SNA Account No.5010037778840 of HDFC Bank, Trivandrum Branch.

- 3) The Director, Women & Child Development Department have requested to accord sanction to transfer an amount of Rs.1654.085 lakh [Central Share from the H/A 2235-02-102-28-01 (P) Rs. 1327.970 lakhs, State Share from the H/A 2235-02-10-28-02 (P) -Rs.326.115lakh, Total -Rs. 1654.085 lakh .] to SNA Account in HDFC Bank, Trivandrum Branch .
- 4) Government have examined the matter in detail and are pleased to accord sanction for transfer crediting the unspent balance of Central and State share amounting Rs 16,54,08,500/-(Rs 13,27,97,000/-Central Share + Rs 3,26,11,500/-State share) for National Nutrition Mission (Sampushta Keralam)for the FY 2021-22 to the State Nodal Account(SNA) 50100377788440 in HDFC bank.
