GUIDELINE TO TRAIN SOCIAL WORK TRAINEES ON KAVAL

KAVAL is an innovative program by Government of Kerala Department of Women and child to socially reintegrate children in conflict with law. The program works in the Kerala state child protection system through multidisciplinary intersectoral approach. The program adopts social work approaches towards social reintegration of children. The social work need to be encouraged to take up their internship in KAVAL and this document forms a guideline for the same.

Aim

To guide the social work trainees in psychosocial care for children in conflict with law in the state of Kerala

Objectives

- To orient the social work trainees on child protection system in Kerala
- To orient the social work trainees on child welfare programs in the state of Kerala
- To educate the social work trainees on laws related to children in India
- To train the social work trainees on KAVAL- Psychosocial care for children in conflict with law
- To give exposure and orientation to the trainees on the role and functioning of varied sectors such as Juvenile Justice Board, DCPU, SJPU, Health and Education and others.

Methodology

The trainees need to take up 21 days/30 days internship in the project. Block placement and concurrent field work can be encouraged.

Schools of social work, Non Governmental Organisations and District Child Protection Officer should follow instructions mentioned below without fail.

Conditions for admitting students from Schools of Social Work

- Students shall be pursuing Masters in Social work (any specialisation).
- Fourth semester students are only allowed to undergo training under KAVAL programme.
- Students will not be permitted to conduct any research activities as part of internship training in KAVAL.
- If the students need to do their dissertation on the topics related to Children in conflict with law following procedures should be observed:
 - Permission should be taken from Juvenile Justice Board
 - Topics should be selected in discussion with the KAVAL team(JJB/ DCPU/ KAVAL NGO)
 - o JJB, DCPU, ICPS and KAVAL team need to be acknowledged in the study

Note for Schools of Social Work

- The school of social work need to specifically mention that the students should be trained in KAVAL. School of social work can either write to DCPU or to the NGO.
- Schools of social work should not give any specific assignment such as studies/ evaluation or other academic activities to be conducted by the students.
- The students will be thoroughly trained in psychosocial social care for children in conflict with law.
- Fourth semester students can be sent for the internship in KAVAL from any specialisation
- As a part of confidentiality that need to be maintained the reports sent to the school of social work will be first submitted to the Internship guide i.e. is the coordinator who will forward it to the DCPU and submitted to the college

Note for Non Governmental Organisation

- The NGO should write to DCPU prior to the placement of interns in social work and seek permission if the school of social work specifically mentions the intern should be trained in KAVAL
- The students should be oriented as per the training guideline given
- The interns should be given orientation on the process of psychosocial intervention for the children in conflict with law
- The interns should be thoroughly trained in Case work, Group work, Laisoning and networking, Reporting, community based interventions etc.
- The interns should be oriented to submit the report in the prescribed format. The reports should be sent to DCPU and get it approved on time to be submitted by students.
- In specific cases if the NGO feels they need to take support from students of schools of social work that can be done with permission from JJB and DCPU (Community based intervention, specific follow up services for children etc.)

Note for District Child Protection Unit

- DCPU should inform JJB about the internship and grant permission to the NGO to train student in KAVAL
- If the interns are sent to DCPU from school of social work to be trained in KAVAL ` then the DCPU can allot the intern to one NGO for the whole month or period of internship.
- The DCPU need to review the progress of interns on a weekly basis
- DCPU should collect the internship report from interns doing internship in KAVAL

- All the reports should be first submitted to the NGO. the coordinator will review the report and forward the report to DCPU who need to forward the same to the school of social work
- DCPU should ensure that confidentiality is maintained strictly
- In specific cases if the NGO or DCPU feels they need to take support from students of schools of social work that can be done with permission from JJB (Community based intervention, specific follow up services for children etc.)

Message to the Interns

- The interns should report to NGO/ DCPU on the date of initiation of internship
- The Interns are bound to follow the instructions of the Internship guide
- The interns should submit daily report in the prescribed format to the coordinator
- The final internship report should be first submitted to the Coordinator who will forward the same to the DCPU and with the signature of the DCPO the report can be submitted to the college
- The interns are expected to maintain strict confidentiality of the cases
- In no situation the details of the child or family should be disclosed.
