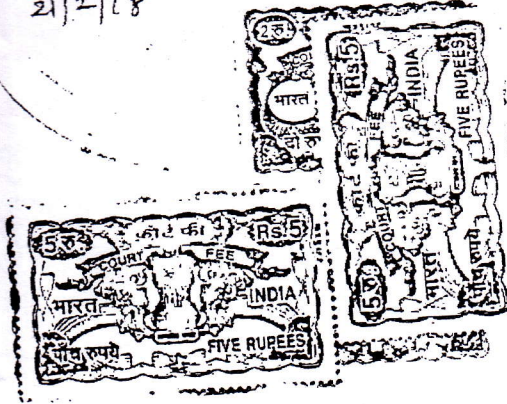

I am submitting this request with reference to the application submitted by Sri. Balachandra Panicker, Kummanode Madom, Pattimattom P.O. Ernakulam for being appointed as the guardian of Smt. Girija Kumari, a mentally retarded person.

As your good self is aware, I have submitted detailed objection dated 1.5.2017 before your good self in the above application filed by Sri. Balachandra Panicker, categorically pointing out facts revealing lack of bonafides on the part of Sri. Balachandra Panicker in preferring the above application. I am Girija Kumari's mother's direct sister and am very much concerned about the welfare of the person of Girija and the only interest Sri. Balachandra Panicker has in Girija is to defeat me and grab Girija's properties.

It is relevant to submit herein that Sri. Balachandra Panicker had filed RSA No.479 of 2017 before the Hon'ble High Court of Kerala, wherein he has taken a contention that Smt. Girija cannot be represented by him since he has not been appointed as guardian. Since the lack of bonafides in Balachandra Panicker's dispute as to his incapacity of representing Smt. Girija Kurmari had to be pointed out

before the Hon'ble High Court by me, I had submitted an application before you good self requesting to hand over a copy of the decision taken by your good self, either by way of final order or interim arrangement, on the guardianship of Girija Kumari, so that the same can be produced before the Hon'ble High Court. Pursuant to the same your good self had furnished me a copy of the notes of the decision taken at your end to appoint Sri. Balachandra Panicker as the guardian of Smt. Girija. However, I have not been served with any formal order whereby Mr. Balachandra Panicker is appointed as guardian of Girija Kumari.

Being a person interested in the welfare of Girija Kumari, who had also contested the proceedings before the committee, I may be given a copy of the formal order appointing Mr. Balachandra Panicker as guardian of Girija Kumari, so that I can approach the Hon'ble High Court challenge in the same.
