Information regarding the quarterly review of Nodal officer, as per Rule 9 of SCs and STs (PoA) Amended Rule 2016, by the end of every quarter, the nodal officer shall review -- (i) the reports received by the State Government under sub-rules (2) and (4) of rule 4, rule 6, clause (xi) of rule 8; (ii) the position of cases registered under the Act; (iii) law and order situation in the identified area; (iv) various kinds of measures adopted for providing immediate relief in cash or kind or both to the victims of atrocity or his/her dependent; (v) adequacy of immediately facilities like rationing, clothing, shelter, legal aid, traveling allowance, daily allowance, and transport facilities provided to the victims of atrocity or his/her dependants (vi) performance of Non-Governmental organizations, the Scheduled castes and the Scheduled Tribes Protection Cell, various committees and the public servants responsible for implementing the provisions of the Act.

(ii) **Period to which the information relates:** December 2015, March 2016, June 2016, September 2016, December 2016, March 2017, June 2017, September 2017, December 2017 & March 2018

(iii) **Description of information required:**

1. Quarterly Review Report of the Nodal Officer including the following:-

- a. Details of the reviewed cases registered under the SCs and STs PoA Amended Act 2015 and action taken by Nodal Officer as per SCs and STs Rule 9(1) (i) during December 2015 to December 2016.
- b. Performance of SCs and STs Protection Cell, related officers as per Rule 9(1)(vi)
- c. Details of cases in case of apparent lapses in registration of cases under PoA Act or registration under improper sections of PoA Act or undue delay in investigations on part of the investigation agencies, where **appropriate disciplinary action recommended for prosecuting the officer u/s 4 of the Act for willful negligence.**
- d. Details of each and every case with details on **adequacy of relief and rehabilitation,** compensation reviewed, according to the scale as in the Schedule annexed to the SCs and STs (PoA) 9(1)(v) Rules 2016.
- e. Detail the status of Implementation of the Rights of victims as per Rule 9 (1) (vii).


