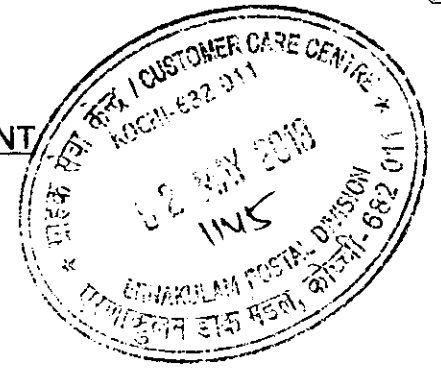

This public authority maybe pleased to provide this applicant with certified document/s of all the above information sought within the timeline specified under the provisions of RTI Act.

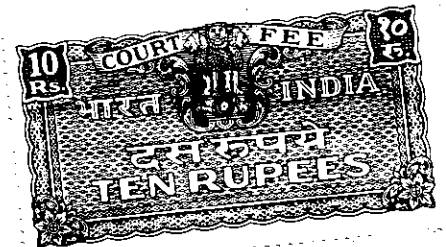

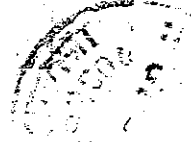

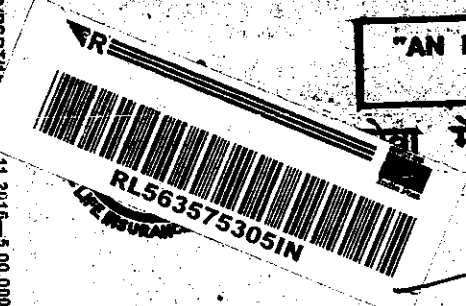

Grievance - Extortion of Money by Mrs.Hena Bahuleyan -Advocate Enrolment
No:k/160/07

I am Lalitha Damodran aged 68 years and a widow residing at Blessings House Thonnikka Kolenchery Ernakulam Dist Pincode 682311 Kerala State. I am living with the pension of my late husband Shri B.Damodaran who passed away on May 15, 2015. I have a daughter who is currently staying with her family about 22 kms away close to Tripunithura Ayurveda College Ernakulam Dist.

This grievance pertains to extortion of money, mental harassment by the family of my direct sister Mrs.Ambili Bahuleyan.Mrs.Hena Bahuleyan (elder daughter of Mrs Ambili Bahuleyan) , Mrs Ambili Bahuleyan (my sister) ,Mr.Bahuleyan (spouse of Mrs Amibili Bahuleyan) and Mrs. Nihala Bahuleyan (youngest daughter of Mrs.Ambili Bahuleyan) residing at Thekevalayil(H),Karippadam P.O Kottayam Dist Pin Code : 686605 Kerala State have been engaging in, verbally abusing , threatening and extorting money from me for over the past 3 years since the time my husband was bed ridden.

During this period Mrs.Hena Bahuleyan and Mrs.Ambili Bahuleyan have together extorted money from me at different intervals amounting to Rs 1,60,000/- (Rs One Lakh Sixty Thousand only) . Mrs.Hena who terminated her pregnancy and divorced her first husband and later married again is currently staying in the house of her second husband c/o Mr.Srikanth at Thattantukudiyil House Kayanand Ooramana PO,Pincode 686663 Ernakulam Dist Kerala State.

Initially , during March 2015 while my husband was bed ridden ,Mrs.Hena came to my house and informed that she was in need of Rs20000/- for some family exigency and that it would be returned by her mother Mrs.Ambili within 2days time. Accordingly the aforesaid amount was transferred to the bank account of Ms.Hena and after a week this amount was transferred back to my bank account by her mother Ms.Ambili. It was only later that I realised it was a strategy carefully planned and executed by Mrs.Hena and Mrs.Ambili to gain my trust.

Since then Mrs.Hena began to demand and extort money from me saying that her mother Mrs.Ambili would return the same with interest within 1 month or a maximum of 3 months . The reasons cited by Mrs.Hena for lending money from me included treatment for mental disorder of her younger sister (Ms.Nihala) , for marriage expense of Ms.Nihala Bahuleyan and for retrieving the gold pledged by her in the bank.

Its informed that Mrs.Hena and Mrs.Ambili has together extorted a total of Rs1,60,000/- between 24.03.2015 & 20.10.2016 .Till date neither this aforesaid money nor its interest has been returned to me .I have umpteen requested over phone and in person to both Mrs.Hena and Mrs.Ambili to return my money . However, I am being abused and threatened by Mrs.Ambili , Mrs Hena and Mrs.Nihala. Mr.Babuleyan, Ambili` s husband has been maintaining a conspicuous silence all this while.

Mrs.Hena Bahuleyan (K/160/07) being an advocate has also threatened me saying that She would soon be appointed as a Judge and as soon as she take charge as Judge, she would take me to task and fix me. Mrs.Hena Bahuleyan has also told me that no police official would ever dare to call or even question me or my family members should I file a police complaint regarding the same. I have also made few attempts to retrieve the money with the support of my dose relatives but all my efforts proved futile.

Considering the above , I request your good office to initiate necessary action against Mrs.Hena and Mrs.Ambili so as to enable me to receive back my money without further delay.

Furthermore , its also informed that this complaint is being send with the support of my daughter Mrs.Zeenia D & family as I am not conversant in English language. My daughter has clearly explained to me the contents of this petition in my mother tongue. Moreover considering my age , may I inform you that my only living daughter Mrs.Zeenia D has legal right over all my assets and money including the aforesaid money (Rs1,60,000/-) .

Look forward to an early redressal.
