Rs.3,03,800/- for such a limb from Hong Cong. As the D.D. in his
favour was came, my son was expired and I was in Deep of Debt who
spent more than Rs.7,50,000/- and was in a Rented House.

I applied to release me the Financial Assistance sanctioned
for the Alternative Limb, towards the Cost and Expenses of his
treatment before the Government of Kerala, through Social Welfare
Officer, Kasaragod. But till date I have not received any reply

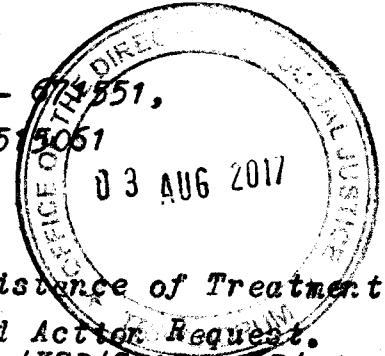
