Live Reforms Department they are not mentioning any usual reservations
given to PwD persons (3% given to benchmark disabled group) and
also highlighting a condition of submission of physical fitness medical
certificate in the Junior Time Scale post of KAS.

In the latest notification of Union PwD for Civil Service Exam
they are providing special reservations and quotas and Age
relaxations to Low Vision disabled persons in all the posts
created in various admin. departments of Union Govt in accordance
with the 'The Rights of persons with disabilities act 2016'. Other State
admin. Services exams are also conducting in accordance with
the disability act 2016 by providing reservations and other relax-
ations (Cj. Raj AS, Karnataka AS).

So requesting all the Kerala Government departments,
responsible for KAS-2018 to take necessary action for
amending / changing the KAS-2018 Rules before the official
notification is published. Directly provide reservation to me and
to all the disabled groups in accordance with the 'The Rights
of persons with disability act, 2016'.
