Sub: Information sought under the purview of the RTI Act-2005 regarding achievement of Uniform Staffing pattern for CDPO/ACDPO posts in ICDS projects in accordance with the GO No. F.No. 1-3/2002-CD-I(Vol.II) Dt. 22/08/03 of MWCD

Respected Sir,
As mentioned in the above subject informations are sought in respect to ICDS projects under the purview of the RTI Act-2005.

That in your letter no 21-1/2016-CD.I Dtd. 7/10/16 I have been informed that uniform staffing pattern has been introduced in ICDS projects from 2003 vide No. F.No. 1-3/2002-CD-I(Vol.II) Dt. 22/08/03 according to which existing strength of CDPOs/ACDPOs will be redeployed to projects where neither a CDPO nor an ACDPO is in position and resultant vacancies will be abolished.

That in letter no F.No.37/1/2015-ME Dtd. 16/11/16 I have been informed that 9047 posts of CDPO/ACDPO have been sanctioned by GOI against 7075 sanctioned ICDS projects as on 30.09.2016. Almost 30% excess posts have been sanctioned undermining the GO No. F.No. 1-3/2002-CD-I(Vol.II) Dt. 22/08/03, Para-5(i), (ii) & (iii). In this context I beg to demand from you under RTI-2005 to inform me categorically state wise that-

1. From 22.08.2003 to 30.9.2016 how many CDPOs have been redeployed to projects where neither a CDPO nor an ACDPO was in position from projects where both CDPO and ACDPO were posted?
2. For this redeployment how many posts of CDPOs were abolished?
3. From 22.08.2003 to 30.9.2016 how many ACDPOs have been redeployed to projects where neither a CDPO nor an ACDPO was in position from projects where both CDPO and ACDPO were posted?
4. For this redeployment how many posts of ACDPOs were abolished?

Please provide me the above information separately for CDPOs and for ACDPOs posts.
