

LLC COMMITTEE, ERNAKULAM.**


As directed by the Chairman of LLC (District Collector, Ernakulam) we visited the residence of the ward Smt.Girija and the other party, Kavukutty Kunjamma, on 18.11.2016 at about 4.30.p.m.


At first we visited the residence of Balachandra Panicker, with whom PWD Girija is residing. When we reached Balachandra Panicker, his wife and son was present there. We met Smt.Girija, who was watching a T.V. Program. She was neatly dressed and appears to be happy also. When enquired she categorically said that she is happy with Balachandra Panicker and his wife and she wants to reside with them. She is not aware of the present petition and other cases pending before the Court. The room provided for Girija is clean and hygiene with attached bathroom and toilet. When asked she is given food by her uncle and aunt. She is not taking any regular medicine for any disease. On appearance her nature is calm and quite. We have also visited the old building in the name of Girija, where she was residing earlier. This building is in a dilapidated condition, not safe for residence.

Thereafter we visited the residence of Kavukutty Kunjamma. At that time Kavukutty Kunjamma, her son, her daughter-in-law and their lawyer was present. In the interaction with them it is understood that they are more concerned with the properties of Girija. They have no reasonable suggestion to take care of Girija. During our interaction they are highlighting the Court cases and its present position regarding the dispute of the properties. Eventhough they pointed out regarding some Court Orders, they were not in a position to produce any document supporting their contention.

After the visit we feel that at present PWD Girija is safe and secure with her uncle Balachandra Panicker, where she residing now. After the visit we returned at about 5.45.p.m.
