G. O. (P) No. 15/2013/SJD. Dated, Thiruvananthapuram, 18th February 2013.

S.R.O. No. 125/2013.—WHEREAS, under sub-section (1) of section 8 of the Protection of Women from Domestic Violence Act, 2005 (Central Act 43 of 2005), the Government shall, by notification, appoint such number of Protection Officers in each district as it may consider necessary and shall also notify the area or areas within which a Protection Officer shall exercise the powers and perform the duties conferred on him by or under the Act;

AND WHEREAS, as per G.O.(Ms) No. 67/2008/SWD dated 2nd December 2008 the Government of Kerala have created 14 posts of Protection Officers in Social Welfare Department to exercise the powers and perform the duties conferred on him by or under the Act;

AND WHEREAS, as the Director of Social Welfare has appointed 14 Protection Officers in 14 districts as per Proceedings No. El-15899/08 dated 27th July, 2010 and forwarded the list of Protection Officers to Government for notifying in the Gazette as provided in sub-section (1) of section 8 of the said Act;

Now, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 8 of the Protection of Women from Domestic Violence Act, 2005 (Central Act 43 of 2005) and in supersession of the notification issued under G.O. (P) No. 21/2007/SWD dated 30th April, 2007 and published as S.R.O. No. 408/2007 in the Kerala Gazette Extraordinary No. 872 dated 10th May, 2007 the Government of Kerala hereby notify the appointment of 14 Protection Officers in 14 districts with effect from the date of assumption of charge as Protection Officers as specified in the Schedule given below:

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 67/2008/SWD dated 2-12-2008, Government have created 14 posts of Women Protection Officers as per sub-section (1) of section 8 of the Protection of Women from Domestic Violence Act, 2005 (Central Act 43 of 2005), in Social Welfare Department with direction to make appointment through P. S. C/By Transfer method, Government have constituted the selection/interview committee with the Secretary, Social Welfare Department as Chairperson, the Director of Social Welfare as Convener and three other members to conduct the selection of 14 Women Protection Officers through by Transfer method. The written examination and interview were conducted by the Institute of Management in Government and the Director of Social Welfare has appointed Women Protection Officers in 14 districts as per proceedings No. E1-15899/08 dated 27-7-2010 from the list of eligible candidates. Under sub-section (1) of section 8 of the said Act Gazette notification is necessary for the appointment of the said Officers. Hence, Government of Kerala have decided to issue necessary notification in the matter.

The notification is intended to achieve the above object.
