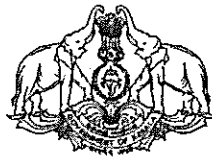

**ORDER**

The Member Secretary, Kerala Women's Commission as per the letter read as 2<sup>nd</sup> paper above has requested to accord revised administrative sanction modifying the Government Order 1<sup>st</sup> cited, by which administrative sanction was accorded for an amount Rs.105 lakhs from the head of account '2235-02-103-90 (03) (P)', for the implementation of Flagship Programmes of Kerala Women's Commission during 2014-15. The Member Secretary has informed that out of the Rs.105 lakhs sanctioned, Rs.45.58 lakhs has been utilized upto February 2015. The details of which are as follows:

Kerala Women's Commission, on the occasion of the International Women's Day. The Member Secretary has therefore requested to accord sanction to transfer an amount of Rs.8.00 lakhs from the amount sanctioned for the programme Pre-Marital Counselling in which savings is expected.

Government have examined the matter in detail and are pleased to accord revised administrative sanction to transfer an amount of Rs.8.00 lakhs (Rupees Eight Lakhs only) from the amount sanctioned for the programme 'Pre-Marital Counselling' to the programmes 'Awareness creation through Documentaries' and 'Awareness creation through Print Media', ie. 4 lakhs to each of the programme.
