In exercise of the powers conferred under sub-sections (1) and (2) of section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016), read with rule 15 of the Juvenile Justice (Care and Protection of Children) Model Rules 2016, the Government of Kerala hereby reconstitute the Child Welfare Committee, Kollam District by appointing the Chairperson and Members mentioned in the Schedule below, for exercising the powers and to discharge the duties conferred on such Committees in relation to children in need of care and protection, as provided under the said Act, namely:-

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) and (2) of section 27 of the Juvenile Justice (Care and Protection of



Children) Act, 2015 (Central Act 2 of 2016) empowers the State Government to constitute one or more Child Welfare Committees for every District for exercising the powers and discharging the duties conferred on them in relation to children in need of care and protection, as provided by the Act. The term of the Chairperson and the Members of the Child Welfare Committee in Kollam District has expired. Hence the Government have now decided to reconstitute the Child Welfare Committee in Kollam District.

The appointment of the Committee shall be subject to the final judgment in WP(C) No.30033/2025 filed by Sri Krishnankutty Nair C. before the Hon'ble High Court of Kerala.

The notification is intended to achieve the above object.
