In exercise of the powers conferred under sub-sections (1) and (2) of section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016), read with rule 15 of the Juvenile Justice (Care and Protection of Children) Model Rules 2016, the Government of Kerala hereby reconstitute the Child Welfare Committees for thirteen Districts in the State (Kollam District excluded) by appointing the Chairperson and Members mentioned in the Schedule below, for exercising the powers and to discharge the duties conferred on such committees in relation to children in need of care and protection, as provided under the said Act, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) and (2) of section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016) empowers the State Government to constitute one or more Child Welfare Committees for every Districts for exercising the powers and discharging the duties conferred on them in relation to children in need of care and protection by the Act. The term of the Chairperson and the Members of the Child Welfare Committees in all districts has expired. The Government have now decided to reconstitute the Child Welfare Committee in thirteen Districts in the State (Kollam District excluded).

The notification is intended to achieve the above object.
