In exercise of the powers conferred under sub-sections (1) and (2) of section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016), read with rule (3) and (4) of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016, the Government of Kerala hereby reconstitute the Juvenile Justice Boards for fourteen Districts in the State with the Members mentioned in the Schedule given below, for exercising the powers and discharging functions related to children in conflict with law, as provided under the said Act, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) and (2) of section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016) empowers the State Government to constitute for every district one or more Juvenile Justice Boards for exercising the powers and discharging functions relating to children in conflict with law, as provided under the Act. The term of social worker Members in all the



Juvenile Justice Boards has expired. Hence the Government have decided to reconstitute the Juvenile Justice Board in fourteen Districts in the State.

The notification is intended to achieve the above object.
