Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 issued by the Government of India and published in the Gazette of India vide GSR 898 dated 21st September, 2016 empower the State Government to constitute a Selection Committee, by notification in the official Gazette, for exercising the powers and discharging the duties conferred on it by the said Rules. Accordingly a Selection Committee was reconstituted under the Chairpersonship of Retired Justice V. K. Mohanan vide G. O. (P) No. 8/2021/SJD dated 9th February 2021 and published as SRO No.156/2021 in the Kerala Gazette Extraordinary No.703 dated 11th February 2021. Since the tenure of the said Selection Committee has expired, the Committee has to be reconstituted with new members and Chairperson. The reconstituted Committee shall have a tenure of three years under sub rule (1) of rule 87 of Juvenile Justice (Care and Protection of Children) Model Rules, 2016. Hence the Government have decided to reconstitute the Selection Committee.

The notification is intended to achieve the above purport.
