B. Particulars of Information required: Please provide the information regarding the One Stop Crisis cells in Kerala.  
C. Purpose of information sought: To social audit the functioning of One Stop Crisis Cells (O.S.C.C.) in Kerala which is of much use to survivors of gender based violence. This information, hence involves larger public interest. Therefore the following information may be provided on that ground:

1. The date on which the Bhoomika centres in Kerala were designated as OSCC? The list of O.S.C.C in the state of Kerala and mention the date on which these centres started functioning as OSCC?
2. The details of staff pattern and the name and designation of the full time staff working in these centres? How many counselors are serving in each centres?
3. Provide the panel of trained Police officers, gynecologist/medical officers, lawyers from KFLSA, clinical psychologist in each centres?
4. How many rape survivors got assistance from Woman Protection Officers from these centres? Name of the Woman Protection Officers in each district. If additional charge is given, mention the name of both districts where she has given such charge. Please mention the home district of each WPO. In how many cases imprest money was dispersed?
5. How many rape survivors/gender baused violence survivors statements were taken in these centres by the trained police till this date?
6. How many rape survivors got assistance from legal counsel from these centres? Name the Legal Counsel. Is she an empanelled lawyer of District Legal Service Authority?
7. How many of them got the medical examination done in these centres other than in labour room or gynecologists consulting room etc?
8. How many cases were in which shelter was provided to the survivor? Provide the list of shelter homes in each district which is authorised to provide shelter homes for survivors of gender based violence/Sexual Harassment?
